Scope of the policy

To help us achieve our vision for 'Taking responsibility for the water environment for good' Yorkshire Water have developed six strategic business objectives. Aim of the policy

As a business we are committed to delivering the balance between significant improvement in environmental performance and drinking water quality, whilst ensuring these changes come at a price that customers can afford.
